Each program consists of teams of ten members, aged 14-17 and three leaders (college age or older). The YCC is an overnight program where the youth and leaders work and live in a park for three weeks. The YSC, a companion program, differs in that it targets at-risk teens and does not include overnight lodging for crew members. In both programs, the crews perform valuable park work including trail and natural resource projects such as removal of invasive species, debris clean-up and view shed clearing.)
